

ORDINANCE NUMBER 2010-08

**AN ORDINANCE TO AMEND ORDINANCE NUMBER 2008-15, TO MODIFY THE 2009 BUDGET FOR THE CITY OF CLINTON, ARKANSAS; AND DECLARING AN EMERGENCY.**

**WHEREAS**, The City of Clinton adopted Ordinance Number 2008-15 which provided for a comprehensive Budget for the year 2009; and

**WHEREAS**, changes in the adopted budget have occurred which caused the actual revenues and expenditures for the year to be different from those projected in the adopted ordinance.

**NOW, THEREFOR, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CLINTON, ARKANSAS:**


**Section 1:** Ordinance No. 2008-15 adopting a budget for the City of Clinton, Arkansas, for 2009 is hereby amended as reflected in Exhibit "A", which is attached hereto.

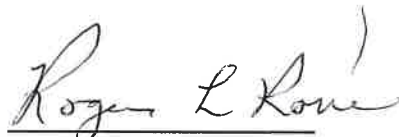
**Section 2:** All parts of Ordinance No. 2008-15 not amended by this Ordinance shall remain the same.

**Section 2: Emergency.** The efficient operation of the City of Clinton, Arkansas, is essential to the public health, safety, and welfare of its citizens. It is important that the provisions of this ordinance go into effect quickly as it imperative to make sure the financial records of the City of Clinton, Arkansas are in proper order for the year ending 2009. An emergency is therefore declared to exist and this ordinance shall be in full force and effect from and after the date of its adoption.
