

ORDINANCE NUMBER 124

AN ORDINANCE TO ANNEX CERTAIN CONTIGUOUS LANDS TO THE CITY OF CLINTON, ARKANSAS AND FOR OTHER PURPOSES.

BE IT ORDAINED, by the City Council of the City of Clinton, Arkansas:

1. That it is the desire of the residents of the City of Clinton, Arkansas, to annex the following described lands in Van Buren County, Arkansas, to said City, to-wit:

$E\frac{1}{2}$, Section 3, T-11-N, R-14-W;
 $SE\frac{1}{2}$ and $S\frac{1}{2} NE\frac{1}{2}$, Section 9, T-11-N, R-14-W;
 All Section 10 North of City Limits, T-11-N, R-14-W;
 All Section 11, T-11-N, R-14-W;
 $SW\frac{1}{2}$, Section 12, T-11-N, R-14-W;
 $W\frac{1}{2}$, Section 13, T-11-N, R-14-W;
 All Section 14 not in City Limits, T-11-N, R-14-W;
 All Section 15 not in City Limits, T-11-N, R-14-W;
 $E\frac{1}{2}$, Section 16, T-11-N, R-14-W;
 $NE\frac{1}{4}$, Section 22, T-11-N, R-14-W;
 All Section 23 not in City Limits, T-11-N, R-14-W;
 $NW\frac{1}{2}$ and $N\frac{1}{2} SW\frac{1}{2}$, Section 24, T-11-N, R-14-W;
 All Section 26 not in City Limits, T-11-N, R-14-W;
 $SE\frac{1}{2} SE\frac{1}{2}$, Section 27, T-11-N, R-14-W;
 $E\frac{1}{2}$, Section 34, T-11-N, R-14-W;
 Section 35, T-11-N, R-14-W;
 $N-3/4$, Section 2, T-10-N, R-14-W;
 $E\frac{1}{2} NE\frac{1}{4}$ and $NE\frac{1}{4} SE\frac{1}{4}$, Section 3, T-10-N, R-14-W.

2. That within the next three (3) years, after the date the annexation becomes final, the City will extend the following services to the annexed area above described:

(A) Fire Protection by the Clinton Volunteer Fire Department.

(B) Police Protection by the Clinton City Police Department.

(C) City Water System Lines to all those who are not currently on the City Water System.

(D) City Water Rates to all those currently on the City Water System.

3. That the question of annexation of said lands shall be put to the qualified electors of the City, and of the area to be annexed, at a special election to be held on MAY 7, 1982.

4. That it is necessary to give the electors as ~~much~~ advance notice of the intended annexation prior to the date called for the special election. It is, therefore, declared that an emergency exists and this ordinance shall be in full force and effect immediately after its passage and approval.

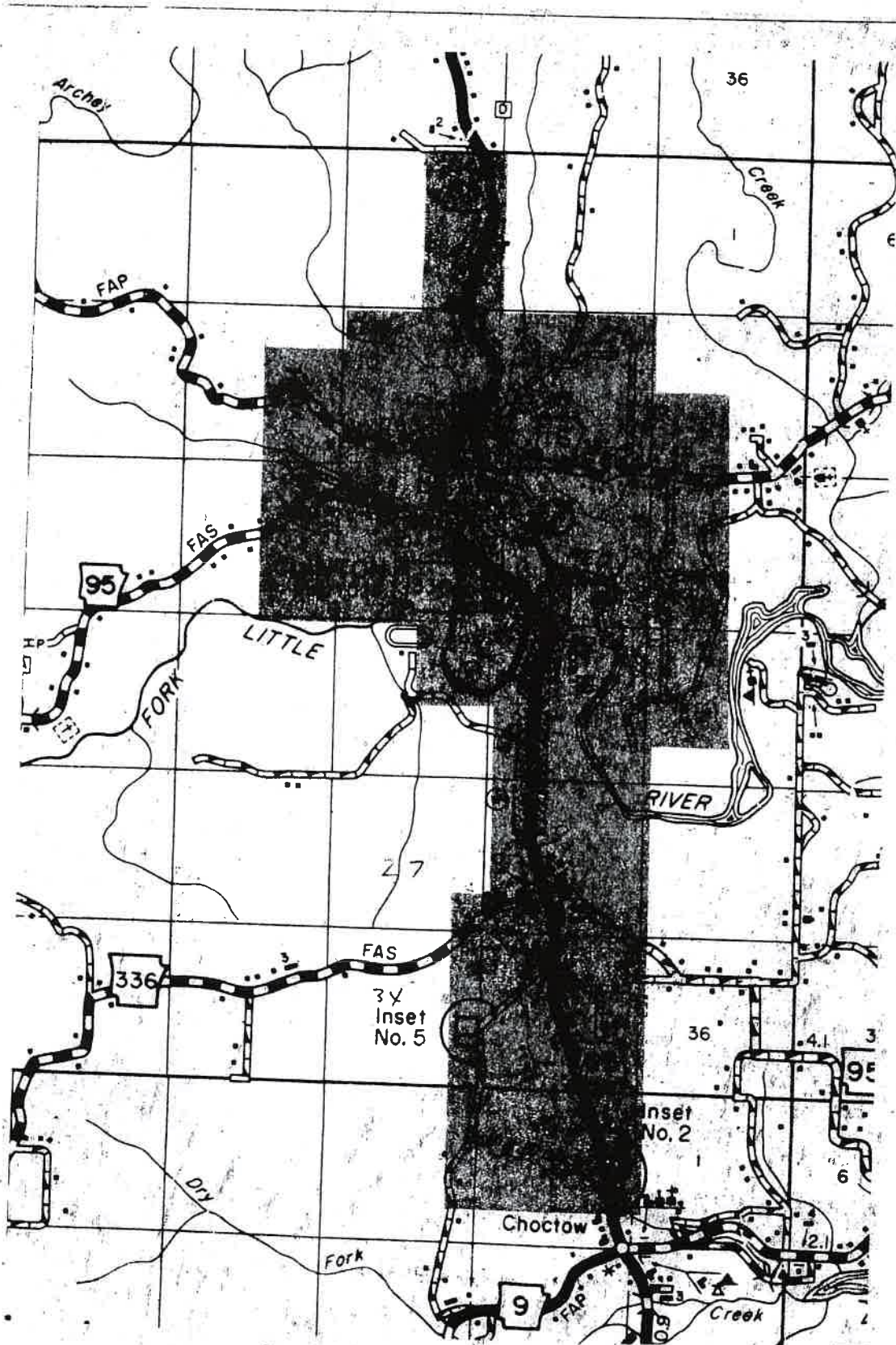
