

ORDINANCE NO. 136

AN ORDINANCE ACCEPTING A TRACT OF LAND AS A PART OF THE CITY OF CLINTON, VAN BUREN COUNTY, ARKANSAS.

Whereas, the County Court of Van Buren County, State of Arkansas, did on the 8th day of April, 1985, here the Petition of Eileen Shannon and others for the annexation of a tract of land into the City of Clinton, Arkansas; and, on that date did enter and Order for Annexation of said tract; more accurately described below, to be organized and incorporated into the City of Clinton, Van Buren County, Arkansas, said tract being:

ALL OF THE NORTHWEST QUARTER OF THE NORTHEAST QUARTER (NW1/4 NE1/4), SECTION TWO (2) TOWNSHIP TEN (10) NORTH, RANGE FOURTEEN (14) WEST, LYING WEST OF U.S. HIGHWAY NUMBER 65, CONTAINING 35 ACRES, MORE OR LESS. (THIS INCLUDES ASLL OF SEDGEFIELD SUBDIVISION, THAT IS NOT IN THE CITY OF CLINTON, ARKANSAS, AS OF THIS DATE.)



ALL OF LOT 39 OF HONEY HILLS SUBDIVISION, THAT IS NOT IN THE CITY OF CLINTON, ARKANSAS, AS OF THIS DATE.

PART OF THE NW1/4 NW1/4, SECTION 13, TOWNSHIP 11 NORTH, RANGE 14 WEST, BEGINNING AT THE SW CORNER OF THE NW1/4, SECTION 13, TOWNSHIP 11 NORTH, RANGE 14 WEST; THENCE S 87° 36' 41" E 1244.46 FEET; THENCE N 03° 03' 21" E 1336.18 FEET; THENCE N 02° 35' 35" E 673.88 FEET; THENCE N 87° 27' W 323.67 FEET; THENCE N 03° 05' 32" E 212.37 FEET TO THE POINT OF BEGINNING; THENCE N 03° 05' 32" E 212.37 FEET; THENCE N 87° 27' W 254.60 FEET TO THE CENETERLINE OF A ROADWAY; THENCE S 03° 05' 32" W 212.37 FEET; THENCE S 87° 27' E 254.60 FEET TO THE POINT OF BEGINNING, CONTAINING 1.24 ACRES, MORE OR LESS.
