

ORDINANCE # 150

AN ORDINANCE SETTING THE SALARY OF THE MUNICIPAL COURT CLERK, AUTHORIZING THE APPOINTMENT OF DEPUTY MUNICIPAL COURT CLERKS, SETTING THEIR RESPECTIVE SALARIES AND APPROVING BONDS.

Be it enacted by the City Council of the City of Clinton, Arkansas.

SECTION 1

The salary of the Municipal Court Clerk of the City of Clinton shall be \$6,300.00 per annum, with said amount to be divided two-thirds to the County and one-third to the City.

SECTION 2

The Municipal Court Judge shall be empowered to appoint one or more Deputy Municipal Court Clerks to serve under the supervision of the Municipal Court Clerk. The Deputy Municipal Court Clerk's salary shall be \$2,000.00 for the year 1987 and shall be modified from year to year as established between the City Council and County Quorum Court.

SECTION 3

The Deputy Municipal Court Clerk shall be empowered to perform all duties and exercise all powers granted to the Municipal Court Clerk and shall post bond in the same manner and amount as required of the Municipal Court Clerk.

SECTION 4

The fidelity bond of the Municipal Court Clerk and all Deputy Municipal Court Clerks in the sum of \$7,500.00 is hereby approved, and the City shall pay one-third of the annual bond premium.

SECTION 5

An emergency is declared to exist and this ordinance shall become effective immediately.

ORDINANCE #151

AN ORDINANCE TO AMEND THE ORIGINAL 1987 BUDGET ORDINANCE OF THE CITY OF CLINTON, ARKANSAS.

WHEREAS there is a need to amend the budget for the safety of the City of Clinton Police officers.

THEREFORE BE IT ORDAINED by the City Council of the City of Clinton.

SECTION 1.

The original budget shall be amended to add an additional \$2,000.00 to the budget for the purpose of purchasing three bulletproof vests, a radio and uniforms for the Police Department.

SECTION 2.

The money shall be transferred from unappropriated general funds of the original budget.

SECTION 3.

This ordinance is approved and passed on this 11th day of December, 1986.
