## ordinance no. <u>2008</u>-04

AN ORDINANCE CONFIRMING THE RATES FOR WATER SERVICES RENDERED BY THE WATER AND SEWER SYSTEM OF THE CITY OF CLINTON, ARKANSAS; AND PRESCRIBING OTHER MATTERS RELATING THERETO.

WHEREAS, the City of Clinton, Arkansas (the "City") owns and operates a water and sewer system (the "System"); and

WHEREAS, it is necessary for the City to confirm its existing rates to be charged for water services rendered by the System;

NOW THEREFORE, BE IT ORDAINED by the City Council of the City of Clinton, Arkansas:

Section 1. The following monthly rates which the City Council hereby finds and declares are fair, reasonable and necessary minimum rates be, and they are hereby, fixed as rates to be charged for basic water services to be rendered by the System.

Monthly Water Rates. All water charges shall be based on water consumption. The amount to be paid by each customer shall be computed on the basis of the following schedule and rates:

Residential Inside City First 1,000 Gallons Next 9,000 Gallons All over 10,000 Gallons	\$8.02 (minimum) 1.67 per 1,000 gallons 1.36 per 1,000 gallons
Residential Outside City First 1,000 Gallons Next 16,000 Gallons All over 17,000 Gallons	\$10.68 (minimum) 1.75 per 1,000 gallons 1.36 per 1,000 gallons
Residential New Line First 1,000 Gallons Next 10,000 Gallons All over 11,000 Gallons	\$12.36 (minimum) 2.68 per 1,000 gallons 1.36 per 1,000 gallons
Commercial Inside City (all but 6" Meters) First 1,000 Gallons All over 1,000 Gallons	\$10.98 (minimum) 1.97 per 1,000 gallons

Commercial Inside City (with 6" Meters) First 1,000 Gallons Next 9,000 Gallons All over 10,000 Gallons

\$200.65 (minimum) 1.97 per 1,000 gallons 1.71 per 1,000 gallons

Commercial Outside City First 1,000 Gallons Next 9,000 Gallons All over 10,000 Gallons

\$12.37 (minimum) 2.12 per 1,000 gallons 1.81 per 1,000 gallons

Commercial New Line First 1,000 Gallons Next 9,000 Gallons All over 10,000 Gallons

\$16.37 (minimum)

3.03 per 1,000 gallons 2.12 per 1,000 gallons

The provisions of this Ordinance are hereby Section 2. declared to be separable, and if any provision shall for any reason be held illegal or invalid, it shall not affect the validity of the remainder of this Ordinance.

Section 3. All ordinances and resolutions and parts thereof in conflict herewith are hereby repealed to the extent of such conflict.
