

ORDINANCE NO. 30-A

Be it ordained by the Council of the City of Clinton, Van Buren County, Arkansas, in regular session assembled, that the following territory heretofore annexed to said city order of the Van Buren County Court, pursuant to section 9496 of Pope's Digest be and the same is hereby accepted as a part of said city: Including the following described territory to-wit:

Beginning at a point on the Southerly right of way line of U.S. Highway No. 65 that is 100 yards easterly from, measured at right angles to, the section line between sections 14 and 15, Township 11 North, Range 14 West in Van Buren County, Arkansas, and being on the easterly boundary line of the Town of Clinton as recorded in the office of the Secretary of State, January 19, 1904, thence easterly and southerly along said right of way line to the section line between Sections 14 and 23; thence easterly along said section line between said sections 14 and 23 to a point on said line that is 500 feet from, easterly from, measured at right angles, to, the center line of said U.S. Highway No. 65; thence Southerly along a line parallel to and 500 feet from, measured at right angles to, the center line of said U.S. Highway No. 65, to the South line of Section 23; thence westerly along said south line of Section 23 to a point on said section line that is 500 feet westerly from, measured at right angles to, the said center line of U.S. Highway No. 65; thence northerly along a line parallel to and 500 feet from, measured at right angles to, the said center line of U.S. Highway No. 65 to a point on said section line between sections 14 and 23; thence westerly along said section line between Sections 14 and 23 to a point on said section line that is 660 feet easterly from Section corner 14-15-22-23; thence in a southerly direction 660 feet from the parallel to the section line between Sections 22 and 23 to a point; thence westerly 1980 feet, more or less, to a point on the center line of the NE1/4 of said Section 22, the said point being 660 feet southerly from the section line between

Sections 15 and 22; thence westerly along said section line between sections 15 and 22 to a point on said section line that is 660 feet westerly from the half section line in section 15; thence northerly along a line that is 660 feet westerly from and parallel to said half section line to a point that is 500 feet southerly from, measured at right angles to, the center line of U. S. Highway No. 95; thence westerly along a line that is parallel to and 500 feet southerly from, measured at right angles to, the center line of said U.S. Highway No. 95 to a point on the section line between Sections 15 and 16; thence northerly along said line between sections 15 and 16; to a point on said line that is 500 feet northerly from, measured at right angles to, the center line of State Highway No. 16; thence easterly and northerly along a line that is 500 feet from, measured at right angles to, the center line of said State Highway No. 16 to a point on said line that is 500 feet westerly from, measured at right angles to, the center line of U.S. Highway No. 65; thence along a line that is 500 feet westerly from measured at right angles to, the center line of said U.S. Highway No. 65 to the westerly bank of Archie Creek; thence southerly along the westerly back of said Archie Creek to the westerly right of way line of U.S. Highway No. 65; thence westerly and southerly along the said westerly line of said U.S. Highway No. 65 to a point on the northerly line of the S 1/2 NE 1/4 of Section 15, being a point on the northerly boundary of said first-mentioned Town of Clinton; all being in Township 11 North, Range 14 West, in the County of Van Buren, State of Arkansas.
